## President's Message

At our August meeting, we added two Primary Members and met the 2024 NFRW and FFRW's membership challenge for all clubs to increase their members by 25%. See the Membership Update on page 2 for the names of all new members.

Our speaker, Lynda Bell, President of Florida Right to Life, gave a thorough explanation of each component of Amendment 4 as it will appear on the ballot and very revealing to what the extreme pro-abortion agenda is and how they are actively coming at each state to forever enshrine unlimited abortions in state constitutions. It is imperative that we defeat this amendment and educate voters to <u>Vote No on Amendment 4</u>! Lynda and others began the PAC, <u>Do No Harm FL</u> to get the word out.

Tracy Boyce, Judi Cleckner and Catherine McNeill were appointed to make up a 3-member Nominating Committee to oversee the candidate application process for the election of KFRW officers, at our November 25th meeting, to 2-year terms to begin at the January 2025 meeting. Officers, consisting of President, Vice-President (up to 4), Secretary, Treasurer, and Past-President, make up the Executive Committee. The current KFRW officers (see names and offices in the lower left red box) are all agreeable to run again for another term, although we encourage other members interested in seeking an officer role based on their interest and skills to give serious thought to applying as we look to 2025 and beyond! Deadline to apply is Sunday, September 29, 2024.

KFRW is coordinating **Poll Watchers** for the Republican Party for the Nov. 5<sup>th</sup> General Election during early voting Oct. 21 - Nov. 2 at the SOE Office and on Election Day.
